Purchase Information

Hi, we're so excited to offer to you our 2023 Dani x Ozzie litter! Below you'll find some information regarding the purchase their pups. We take the utmost care in placing our pups with their new families.

How To Reserve A Pup

We hope you've had the chance to keep up with our social media and watch the pups as they grow.

- No deposits are required to be placed on the waiting list prior to the pups being born. It is first come, first serve. I ask that you fill out an application and, upon approval, let me know you'd like to be put on the list.
- I usually start accepting deposits when the pups are around three weeks old. At which point, I will utilize the list and, based on your number, you will be contacted and will be able to pick your pup out in week four to week five, depending on pups' maturity.

NOTE: I prefer buyers to pick out their pups in person as I think it is more who the pup picks as their person, versus who the buyer picks as their pup. However, in the event of an out-of-town purchase, I will allow you to pick your pup via zoom.

Deposits

- Deposits are non-refundable should the buyer back out unless it is extenuating circumstances. In which case, I may make an exception, but it is up to my discretion on a case-by-case basis.
- Should I decide the sale is not in the pup's best interest and I back out, then the deposit will be refunded in full. I reserve the right to decide the sale is not in the pup's best interest at any point up until the final payment is received at the time of your pup's pick up.

- Once I start accepting deposits and you are notified, then a deposit is necessary to keep your spot. You will have 24 hours to make the payment (unless it is by check) or your spot will be forfeited and offered to the next person.

Price and Payment

Price: Call/Text/Email

Deposit amount: \$500

- Payments are to be made in **cash or Venmo/PayPal**, cash is preferred. I will make an exception for checks on a case-by-case basis. Should you be mailing a check for the deposit, if it is not received within 5 business days, you will forfeit your spot on the list and it will be given to the next person.
- The remaining payment is due when you pick up your pup. Should you fail to make the payment, then you will forfeit your spot on the list and it will be given to the next person.

Pup Visitation and Pick Up

- I will notify you when the pups are old/mature enough for you to come pick out your pup. I will pick an evening/weekend day and will be scheduling several back-to-back appointments. Each appointment will be 45 minutes long. Please be respectful of the next appointment's time. I will notify you when your appointment date is set.
- Pick up of your pup will depend on your pup's maturity. Some are ready to go at 6 weeks (especially the males) and some I hold back until 8 weeks, based on pup's individual maturing. I will notify you when your pup is ready to go and schedule a time for you to pick up your pup. Please be ready to pick up your pup in the 6- to 8-week timeframe.

Location

- I am originally based in Wayland, New York, however, I am currently located in the Rapid City, South Dakota area. I will be here for the duration of Dani's litter and sale of the pups. I intend to still advertise to my client base in Western New York as well as the Rapid City and surrounding areas.

Should you want to purchase a puppy and you are out of town, travel arrangements will be the buyer's responsibility and financial obligation.

I may potentially be planning a trip back to NY in mid-May, which would be right around when the pups are ready to go. I will be playing that by ear but am open to the possibility of bringing a pup/pups for pick up in Wayland, New York. This arrangement will be played by ear based on my travel plans and nothing is set in stone yet. Let me know if that's something you're interested in and I'm open to discussing it.

Sire and Dam Information

Sire: *Innishfree's Blazing Red Ozzie* is owned by Linda Kelly with Innishfree Handpicked-Puppies Labradors & Japanese Chins in Rapid City, South Dakota. Linda has raised Labrador Retrievers for the past 15 years. She has used Ozzie in her breeding program, and he's produced incredible pups. She has been downsizing this past year and has spayed her females but has kept Ozzie intact because she still wants to share him with others.

Ozzie is a Fox Red Lab and was bred for hunting and has a great hunting pedigree, although, he wasn't specifically trained for that. He has the motivation and drive of a hunter and has produced many great hunting dogs but also knows when to shut it down and is a great family pet. Also, Ozzie's aunt is a task-trained service dog. He's a handsome fella with a rockstar personality. Ozzie is AKC registered.

Dam: Oh, Dani Girl is owned by Laura Schmieder, currently residing in Rapid City, South Dakota. Laura bought Dani in 2017 from a family friend's litter when she lost her chocolate. She knew without a shadow of a doubt that her next pup was coming from her friend's dogs. Laura's friends owned both Dani's parents and grandparents and Laura had the opportunity to observe these dogs for years and was so impressed with them and the pups they produced she jumped on the chance to own a pup from them.

Dani is a gem of a dog and was by Laura's side continuously for the first two years of recovery after her car accident in 2018. Dani is equal parts playful, cuddly, and is extremely intuitive and likes to communicate with her human using her eyes. She's great with kids, other dogs and loves adventures.

When Laura started traveling to see different specialists around the country following her accident, Dani was public-access trained and went with her everywhere. Dani was a huge support during that time and was incredible at anticipating Laura's needs. She is currently being task-trained as a migraine alert dog and is excelling in that capacity.

Dani has produced very intuitive pups and a phenomenal hunting dog came out of her last litter.

Dani is not currently registered as her grandfather's papers were misplaced during a move and copies of the papers were never acquired. Laura is currently attempting to track down the breeder that her grandfather was purchased from in order to get the needed paperwork to get her registered. Dani has been DNA tested and is 100% purebred, she has also been microchipped and OFA tested for hips and elbows.
